### Eligibility

The promotion is open to all Alaska residents, who are both 18 years or older and physically in the state of Alaska on September 1, 2022, except the employees and immediate families (spouses and parents, siblings, and children and their spouses) of GCI Communication Corp. ("GCI"), their affiliates or subsidiaries, their advertising agencies, and any other company involved with the design, production, execution, or distribution of promotion materials for GCI.

### How to Participate:

Once the app is downloaded, entrants will sign in (using First Name, Last Name, and Email Address, and other information as required by the GooseChase App). Entrants will then have the opportunity to complete a checklist representing that they have completed all 4 wellness challenges. Entrants who have successfully registered and represented that they have completed all 4 wellness challenges by the deadline of September 30, 2022, and who meet all other eligibility requirements explained herein, will be entered to win.
